Remembering Marilyn Shipley

Brookings Nite FCL wants to recognize our recently passed member, who was so instrumental in many **FCE** areas. Here are some of our thoughts for the **Oregon FCE News**, hopefully not too long for a story of a dedicated **FCE** member.



About 50 years ago, a small group of young mothers formed an evening Extension Study Group called **Brookings Nite**. The early founders had young children and some worked, so the group found it easier to get out of the house when Dad was home to watch the kids. As **Marilyn Shipley** often said, "It was the only time we got to talk to adults."

Brookings Nite is still mourning the loss of our long time-friend and member, **Marilyn**, on **October 25, 2014**. She lead us all through many changes in our group and in **Oregon State Extension Service**. The mother of a large family, she was married at 15 and valued the opportunity she never had to expand her own learning. **Marilyn** thought it would be a grand idea for us all to leave home for a few days and attend **Mini-College at OSU**. For years, she piled as many of us as she could in her motor home and we drove the 6 hour trip midst laughter, card games and general relief to have time for ourselves. She and other members of this small group became parts of the **State Council** and the **Mini-College** committee.

When a new opportunity in the form of **Family Community Leadership** was begun to help rural **Oregon** women learn how to take on leadership roles in their communities, **Marilyn** was tapped to be the volunteer chair along with **Greg Tillson** from the **Extension Service**. She took to it like a duck to water (in Beaver country), and served **FCL**

for several years. She was so proud of the lessons and leadership **FCL** provided for rural women. Indeed, many local women learned to facilitate, organize, speak up, and run for office. When that program melded into **Extension Study Groups** and became **Family Community Education**, it was partly due to her efforts.

One of the leadership projects in her own community is the **Brookings Community Bazaar**,

held each year in early **November** for somewhere around 45 years...we aren't sure. **Marilyn** and her friend, **Vangie Andreason**, felt that the small non-profit groups in the area should hold their holiday bazaars under one roof, making it an easier shopping venue for customers instead of running all over town, and bring more profits to the groups. First held in a local church hall, the idea was so successful that the bazaar moved to a local school, then to a larger gymnasium and finally to two gyms close together. Today's event hosts over 100 vendors and is a highlight of the holiday season. Not only did **Marilyn and Vangie** do all the hard setup work those early years, but **Marilyn** decided to also hold a luncheon with a hot chicken casserole, homemade pies and molded salads. Dwindling group membership forced us to cancel the lunch a few years ago, much to the dismay of our customers who still ask for it. When **Vangie** asked **Marilyn** once why they were doing this, **Marilyn's** famous and oft repeated answer was, "For the honor and the glory, **Vang**. The honor and the glory." We tell ourselves this each year as we stretch our small group to put on one more bazaar.

There are many more stories to tell, like running the **Rogue River** (corn dog) Pup booth at the county fair, providing **4-H** camping scholarships and women's learning and cultural opportunities with bazaar and pup booth proceeds, leading church youth groups on extended journeys, organizing river float trips, potlucks and more, with **Marilyn** at the center or the helm. When **Mini-College** closed, the group continued on its own to take a long weekend of learning with one another, staying together packed into hotel rooms or vacation rentals. **Brookings Nite** is the only **FCE** group left in all of **Curry County**, and **Marilyn's** leadership and love are much of the reason. Her big heart, strong leadership and loving friendship will continue to support us all.

District Reports 2014 & 2015

Reports from Spring Board Meeting

District III, by Sally Wyffels

We have 97 members and 10 study groups. **October** thru **February 2015** volunteer hours reported in **Marion County** totaled 97 FCE hours, 253.5 other hours, **Polk County** reported 11 FCE hours, 170 other hours, **Yamhill County** reported 574 FCE hours, 1151 other hours and 296 with kids.

These hours consisted of: FCE trainings, lesson planning, study group officers, County Council, mailing State FCE News and MPY Tri-line News, writing lessons, writing articles for newsletters, attending State FCE meetings, National FCE meeting and planning regional meeting.

Other hours and "kids" hours: SMART program in schools, tutoring students, teach Sunday school, knitting booties, hats and sewing blankets, "books for Babies Project" bags and bibs, hospital volunteering, senior centers, transportation for seniors and shopping for them, church, Lions and American Legion, Eastern Star and Elks, needlepoint club, food bank, libraries, clothing for homeless, adult literacy, working with 4-Hers, serving on Yamhill Extension Advisory Committee, Sheridan Museum, Yamhill Heritage Center and Museum, Habitat for Humanity, Homeward Bound (pets), hospice, state fair and community theaters.

Donations from the three counties have been made to the 2016 state conference, extension service, layette program, books for babies, gift baskets for Spring Festival, food and money to food banks, the MPY Tri-Line News and FCE web-site.

Yamhill/Polk held their Spring Festival in March with 50 in attendance. Special guest included Oregon State FCE President, Patti Malanaphy and Lendamai Poole from District X; District VI Co-Directors, Marilyn Thompson and Loretta McDonald, and Ana Kramer; from District IV Linn County President, Vicki Graves; Marian Pennington, Vice-president and several of their members; also several members from Marion County attended.

Amity had two participants in the Character Counts Program.

District III and IV have been working together in preparation of the 2016 State FCE Conference.

**District V, by Rosalee Ratto**

As of **December 2014**, Jackson County had a membership of 65. Klamath County has 19 members consisting of two study groups.

Volunteer hours for Jackson County were 1438 for FCE, 1824 for other hours. Donations given: \$4000 to OSU student, 4-H projects, memorial scholarships, Scholarship Dessert for high school students, a high school project, assistance for those attending State Conference, Christmas charities, ACWW, assistance toward FCE website. Also donated items to fill 73 bags for newborns/teens and thread to send to India.

Study Groups participate in a variety of activities including: church choirs, American Red Cross, hospital volunteering, cleaning and maintenance for the elderly and churches, pedicure for elderly, medical transport, notary service, attending community events such as Jacksonville Beekman House Guide, Hanley House Tour Guide, Friends of the Library, School Board meetings, Historical Society, Festival of Trees, Senior Center Quilting, Christmas Store for Needy, Button Demonstrations, Shoebox assembly, Food Pantry, Gifts for needy children, Crater Rock Museum, Literacy Counsel, FFA dinner and auction. Groups spent considerable time preparing for meetings, auditing treasury books, writing and typing newsletters, half-yearly reports, phone contacts, training for presentations at meetings, state conference and study group paperwork, Alumnae meetings, Art and Essay Contest.

Co-District Directors attended two meetings in Klamath County.

Klamath County volunteer hours for FCE and all others was 2,360 for the Contemporaries for FCE and other projects; Chiloquin had a total of 3,412. Both groups are staying very busy with raising money for scholarships and collecting items for the VA and newborns. All of our members volunteer in several areas: Chiloquin Gallery, the Ambulance, the Bloodmobile for the Red Cross, the Bazaars, the Rocky Mountain Foundation, the Chiloquilters for project Linus, library, school and assisting senior citizens. County Council is busy putting together a Teen Parenting KOL which we are hoping will not only be helpful to younger ages but also peak their interest in our organization.

Fruitvale study group gathered clothing at **Christmas** time for the **Christian Aid Society** in **Walla Walla.** It was mainly for children, knitted caps, socks and underwear. They are supporting the "**Character Counts**" program and give \$25 to the winner in **Umatilla Co.**

Giddy Up Go study group has been donating items to homeless **Vets** through the **VFW Veteran Rep.** At **Christmas** they picked three names off the "**Giving Tree**" to get presents for and gave things to the elderly at nursing homes as well. They regularly gather coins for friendship. They had a table at the **Eagle's Bazaar for FCE,** handing out information to several interested

persons. Their **FCE** volunteer hours were 23 and others were 144.

**District X by Phyllis McIntire and Jean Baker**

**Washington County** has 5 groups and about 50 members. They have logged 921 **FCE** hours and 3,385 hours of other volunteer work. These hours include serving at soup kitchens, **Red Cross** blood drives, church activities, museums, **4-H** and making quilts.

**Clackamas County Council** has 8 groups and 106 members. **Highland, Woodmere and Mt. Pleasant** study groups attended the **Holiday Fair** put on by **Washington County FCE.** **Carus** study group visited the **Oregon** place where they train guide dogs and a foundry in **Boring.**

**Clackamas County Home Study Groups** put in 1,343 volunteer hours for FCE projects and 3,729.25 volunteer hours working at churches, making hats for new born babies and many other projects in the area. **Betty Pribil** from **Happy Valley** study group was recognized in the **Clackamas County Review** for her outstanding work providing 6,038 quilts over the years. Some of her quilts were donated to the **Clackamas County Abused Children** program, others were donated to outreach ministries of her church. She is **Clackamas County "Heart of FCE" recipient for 2015 and the Oregon FCE winner.**

**Woodmere** study group delivered 117 children's books to **Shriners Children's Hospital.**

These study groups have donated toys, raised money for **4-H** campships, **Guide Dogs for the Blind,** food banks, **Oregon FCE web-site** and other awards.
