Each section has a kitchen, dining area, den, entertainment center and outdoor courtyard. Each resident has a private room. The separate dining room per section is nice because the food is served up as they order it so the food doesn't get cold as it does when served up in a cafeteria and served all at the same time as it is in most care facilities.

The residents' rooms are very roomy and comfortable and make the residents feel like they are at their own homes.

Lauren Murray, from Newport High School was one of the speakers. Lauren was the District contest winner of the Veterans of Foreign Wars, Voice of Democracy Essay.

Kyle Smith and Cramer Strader-Sprague from Greater Unified Albany Vexillological Association (GUAVA), spoke to us on Flag History and Creation of the City of Albany Flag. They told us of the process that is taken to develop the design of a flag, the do's and don'ts.

**Curry, Jackson & Klamath Counties**

Spring Board report: Brookings Nite does a table at the Community Christmas Bazaar with crafts done by members for sale, a "white elephant" Christmas tree with gifts for \$1 and coffee/soda/water sales for vendors. We also offer FCE information to those who inquire. We have 14 paid members.

Members contributed 529 volunteer hours, they include bazaar work, Rotary, church, college foundation board, advisory board for local nursing home, food bank and many other activities. The Bazaar in November is our big one, we have booths for at least 10 community organizations and offer free space for some youth groups to have booths. This is the 47<sup>th</sup> year. It started as an effort to bring the small bazaars around town under one roof and it grew from less than 20 vendors to over 100. Funds, after expenses, have supported 4-H camp scholarships, donations in memory of passed members to 4-H and local animal shelters, pay dues for all members to State and National FCE, food banks, helped local church to acquire a handicapped elevator.

This year we started a new tradition of having a birthday lunch each month to celebrate those members whose special days were that month. Everyone brings cards for those celebrating, lunch is at a location chosen by the honorees and it is no-host. Usually some nice person brings a birthday cake. We held one "Game Day", at a member's home to play board games and have fun together.

Jackson County has 61 members with 1,324 FCE volunteer hours and 1,002 other hours. Hours come from lesson presentations, making stuffed animals for children, History clubs, Cemetery, caregiving, transportation, schools, food banks, newsletters, Character Counts Contest, thread for India, recruiting new members and many other projects.

Klamath County has 18 members in the two groups. They do a lot of community service and are active in the FCE organization. Each group teaches a lesson/program each month and uses many of the State and National FCE prepared materials. They collect "Coins for Friendship".

They have a total of 756 FCE volunteer hours and 910 other hours. The groups have collected items and put together 114 books for newborns packets. Half were delivered to the Tribal Health Office in Chiloquin and the other half to WIC to be delivered to families in Klamath County. Both places are very appreciative of the packets as are the recipients.

Klamath County has donated to Vet organizations for many years. They collect hygiene kits for the VET Clinic. To date 127 packets have been delivered and another 20 are ready for delivery to the Disabled American Veterans. We will walk on April 28 for the ACWW Women Walk the World.
